(ii) Two Bid System (Financial & Technical Bids): Bids should be put in two separate covers placed in one larger envelope along with Demand Draft of 2% of cost estimated of the refurbishment as Earnest Money Deposit (EMD) in the name of Embassy of India, Harare . (iii) The tender issuing authority reserves the right to withdraw/cancel the Tender for any reason whatsoever after publication/award of the contract. (iv) Payments/Bills would be settled in two instalments (90% would be paid after successful completion of the work) and second instalment that would be 10% of the total amount would be paid/released after six months of the completion of the work.
